ORDER CORRECTING ORDER *NUNC PRO TUNC*

On March 20, 2019, the Commission issued an order in response to a Joint Motion of Ameren Missouri, Staff, Public Counsel, and the Missouri Industrial Energy Consumers (MIEC). In its order, the Commission further modified its 2012 report and order regarding Union Electric Company d/b/a Ameren Missouri's continued membership in the Midcontinent Independent System Operator, Inc. (MISO). That order will become effective on March 30. The Commission has become aware of an incorrect date in its March 20 order.

In ordered paragraph 2.D, the Commission ordered Ameren Missouri to file a pleading regarding its continued membership in MISO by November 15, 2023. In fact, that date should have been March 15, 2023, as was requested in the Joint Motion. The Commission will correct its order accordingly.

THE COMMISSION ORDERS THAT:

1. Ordered Paragraph 2.D of the Commission's March 20, 2019 Third Order Modifying 2012 Report and Order is corrected *nunc pro tunc* to require Ameren Missouri to file the pleading required by that paragraph by March 15, 2023.

2. This order shall be effective when issued.
