On March 20, 2019, the Staff of the Commission filed motions in each of these cases requesting the Commission dismiss the portions of Spire Missouri Inc.'s applications that seek to recover the costs incurred in connection with infrastructure system replacement surcharge (ISRS) replacements made during the period October 1, 2017 to June 30, 2018, to the extent such costs were not recovered in Spire Missouri's immediately preceding ISRS proceedings, File Nos. GO-2018-0309 and GO-2018-0310. Because of the short statutory timeframe for an ISRS case, and because this issue is related to an issue already set out in Staff's recommendation for which responses are due March 22, 2019, the Commission will shorten the time for responses to Staff's motions.
