On September 21, 2023, Union Electric Company d/b/a Ameren Missouri filed notice that it intended to file an application for permission and authority to issue and sell additional long-term indebtedness. On November 13, 2023, Ameren Missouri filed its application, a request for a waiver of the 60-day notice requirement, and a motion for expedited treatment. The Commission will direct its Staff to file a recommendation regarding Ameren Missouri’s application.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file its recommendation, or a request for an extension of time stating when it expects to file its recommendation, no later than December 11, 2023.
2. This order shall be effective when issued.
