**ORDER DIRECTING RECOMMENDATION
ON SECOND REVISED TARIFF**

Effective Date: November 15, 2023

On August 30, 2023,¹ the Commission issued an *Order Granting Certificate of Convenience and Necessity* (CCN) in this matter, to be effective on September 29. The order granted Spire Missouri, Inc., d/b/a Spire, a CCN to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Johnson County, Missouri, as a further expansion of its existing certificated area.

Paragraph 1.c. of the order states, “Spire shall file an updated tariff sheet incorporating Section 16, Township 46 North, Range 25 West for Johnson County.”

On August 31, Spire filed a revised tariff sheet, bearing an effective date of September 30, and assigned Tracking No. JG-2024-0029, which incorporated the new certificated area.

At the request of the Commission, the Staff of the Commission (Staff) reviewed Spire’s revised tariff sheet and, on September 6, filed a recommendation that the

Commission approve the revised tariff sheet. On September 14, the Commission approved the revised tariff sheet – P.S.C. No. 9, First Revised Sheet No. 21.11 Cancelling Original Sheet 21.11 – to be effective on September 30.

On November 8, Spire filed a revised tariff sheet – P.S.C. No. 9, Second Revised Sheet No. 21.11 Cancelling First Revised Sheet 21.11. This tariff sheet was assigned Tracking No. JG-2024-0062 and has a proposed effective date of December 8. Spire states that the First Revised Sheet 21.11 incorrectly incorporated Section 18, Township 46, Range 31 West in Johnson County. This revised tariff sheet purports to correct the certificated area to comply with the Commission’s August 30th order.

The Commission will direct Staff to review the second revised tariff and file a recommendation as to whether the Commission should approve it as complying with the Commission’s August 30th order.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Spire’s second revised tariff sheet (Tracking No. JG-2024-0062) no later than November 21, 2023.
2. This order shall be effective when issued.
