ORDER OPENING AN INVESTIGATION

On March 11, 2019, the Manager of the Manufactured Housing and Modular Units Program of the Public Service Commission filed a motion asking the Commission to open an investigation into the installation and set-up practices of Brune Mobile Sales, a certified dealer of manufactured housing units.

The Commission will open this case to facilitate the Manager's investigation. In addition, an open case will afford the Manager an opportunity to report to the Commission as appropriate.

This is only a fact-finding investigation and is not a contested case. The Commission will not take any action regarding Brune Mobile Sale's practices within the confines of this investigation. If the investigation reveals that any such action is appropriate, the Manager may file a formal complaint or other appropriate pleading within a new file to institute contested case procedures.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall undertake an investigation of Brune Mobile Sales' installation and set-up practices.
2. Staff shall file a progress report regarding its investigation no later than September 27, 2019.
3. This order shall be effective when issued.


