ORDER GRANTING APPLICATIONS TO INTERVENE

Union Electric Company d/b/a Ameren Missouri filed its 2023 Integrated Resource Plan (IRP) on September 26, 2023.¹ Renew Missouri Advocates d/b/a Renew Missouri, Grain Belt Express, LLC, Natural Resources Defense Council, Clean Grid Alliance, Consumers Council of Missouri, Midwest Energy Consumers Group, and Council for the New Energy Economics filed timely applications to intervene.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless otherwise ordered by the Commission. More than ten days have passed since the applications were filed and no party has responded to any of the applications to intervene.

Commission Rule 20 CSR 4240-2.075(3) provides that the Commission may grant a motion to intervene if it finds that the proposed intervenor has an interest that differs from that of the general public and that may be adversely affected by the final order arising from the case, or if granting the proposed intervention would serve the public interest. The Commission finds that allowing each of these applicants to participate in the review of Ameren Missouri's IRP will serve the public interest. The Commission will grant each of the applications to intervene.

6. The application to intervene of the Midwest Energy Consumers Group is granted.
7. The application to intervene of the Council for the New Energy Economics is granted.
