ORDER DIRECTING LIBERTY RESPONSE

On July 28, 2023, The Empire District Electric Company d/b/a Liberty filed its *Notice of MPPM Submission*. This was Liberty's first annual market price protection mechanism (MPPM) compliance filing. On November 13, 2023, the Office of the Public Counsel (Public Counsel) filed its motion in response to Liberty's MPPM submission asserting that Liberty has the incorrect PPA replacement value, and that the correct value is \$0. Public Counsel requests that the Commission to order Liberty to refile its MPPM compliance filing to reflect a PPA replacement value balance of \$0.

The Commission will direct Liberty to respond.

THE COMMISSION ORDERS THAT:

1. No later than November 28, 2023, Liberty shall respond to Public Counsel's motion.
2. This order shall be effective when issued.
