# **ORDER GRANTING LEAVE TO DISMISS COMPLAINT**

On March 29, 2019, Complainant, Stella Lucy, filed a *Dismissal with Prejudice*. Commission Rule 4 CSR 240-2.116 (1) states that "[o]nce evidence has been offered or prepared testimony filed, an applicant or complainant may dismiss an action only by leave of the commission, or by written consent of all the parties." Evidence has been offered, and prepared testimony has been filed in this case. The Commission will, accordingly, treat Ms. Lucy's *Dismissal with Prejudice* as a motion for leave to dismiss per Rule 4 CSR 240-2.116(1). Ms. Lucy's motion asserts that the parties have "reached an agreement which resolves their dispute." The Commission, accordingly, finds good cause to dismiss the Complaint.<sup>1</sup>

## THE COMMISSION ORDERS THAT:

1. Stella Lucy's Complaint against Union Electric Company d/b/a Ameren Missouri is dismissed.
