ORDER APPROVING RESRAM TARIFF FILING

Issue Date: November 16, 2023 Effective Date: December 1, 2023

On September 29, 2023, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed a revised tariff sheet to adjust charges related to the company's approved Renewable Energy Standard Rate Adjustment Mechanism (RESRAM). The revised tariff sheet bears an effective date of December 1, 2023. The Commission directed notice, set an intervention deadline, and ordered its Staff to file a recommendation.

On November 9, 2023, Staff recommended the Commission issue an order approving the tariff effective November 30, 2023. Evergy Missouri West's total RESRAM expense balance as of August 31, 2023, was \$11,854,577. The annual Allowable RESRAM Revenue Requirement is \$7,500,363 which is 1% of retail billed revenues from ER-2022-0130 in the amount of \$750,036,250.

¹ Evergy Missouri West responded on November 9, 2023, stating that the actual tariff effective date is December 1, 2023, not November 30, 2023.

Using Evergy Missouri West's projected energy level of 8,161,410,268 kWh and the revenue requirement mentioned above, the RESRAM rate is \$0.00092. Customers using 1,000 kWh per month will see a \$0.04 increase per month.

On the basis of Staff's examination of Evergy Missouri West's tariff sheet, the Commission finds the tariff sheet conforms to Commission Rule 20 CSR 4240-20.100. The Commission concludes that the proposed RESRAM adjustment tariff should be approved to become effective on December 1, 2023. The Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet, filed by Evergy Missouri West and assigned Tariff No. JE-2024-0042, is approved and shall be effective on December 1, 2023:
