On September 28, 2023, Dranel J. Clark and Aquilla Canada ("the Complainants") filed a complaint with the Commission against Union Electric Company d/b/a Ameren Missouri.

On October 27, 2023, Brett Felber filed a *Motion to Intervene*, asserting, among other things, that he "had a complaint that expresses siminlar [sic] actions as the Complainants [sic] complaint…"

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting intervention would serve the public interest.

Mr. Felber's motion does not demonstrate that he has an interest in this matter different from that of the general public and that he will be adversely affected by a final order arising from this case. Further, the Commission finds nothing in Mr. Felber's motion suggesting his proposed intervention would serve the public interest.

Therefore, the Commission will deny Mr. Felber's motion to intervene.
