## ORDER GRANTING MOTION FOR EXTENSION

Issue Date: November 17, 2023

Effective Date: November 17, 2023

On October 26, 2023, The Empire District Electric Company d/b/a Liberty filed a revised tariff entitled Limited Large Customer Economic Development Rider, Schedule SBEDR. The tariff bears a November 25, 2023 effective date.

The Commission ordered responses no later than November 9, 2023. The Commission's Staff (Staff) filed a Motion for Extension until November 16, 2023, which the Commission granted. On November 16, 2023, Staff filed another motion for extension, noting that Liberty had filed substitute tariffs on November 16, 2023, and that it needed time to review the substitute tariffs.

The Commission will grant Staff's motion. However, because the tariffs bear an effective date of November 25, 2023, the Commission will grant only a brief extension.

### THE COMMISSION ORDERS THAT:

1. The Motion for Extension is granted.
2. The Staff of the Commission shall file a Recommendation regarding the amended application no later than November 21, 2023.

3. Any other party who wishes to respond to the amended application shall do so no later than November 21, 2023.

4. This order shall be effective when issued.
