On March 16, 2022, the Commission issued its *Revised Order Granting Variances* and *Granting Waiver* in this matter. That order was appealed by the Office of the Public Counsel (OPC) to the Missouri Court of Appeals for the Western District. The Western District Court of Appeals issued an opinion on December 27, 2022, which upheld the Commission's order. OPC appealed the Western District Court of Appeals ruling to the Missouri Supreme Court. On August 15, 2023, the Missouri Supreme Court issued an opinion reversing the Commission's order and remanding the case to the Commission to enter a new order consistent with its opinion.

The Commission will now direct the parties to file responses on how they would like the Commission to proceed.

- 1. No later than December 1, 2023, any party wishing to be heard on this matter shall submit a response expressing its opinion on how the Commission should proceed.
