On September 27, 2023, Union Electric Company d/b/a Ameren Missouri filed the above-reference tariff to change its Weather Normalization Adjustment Rider (WNAR). That tariff bears an effective date of November 1, 2023.

Staff filed a recommendation on October 10, 2023, asking the Commission to approve the tariffs. No party has objected.

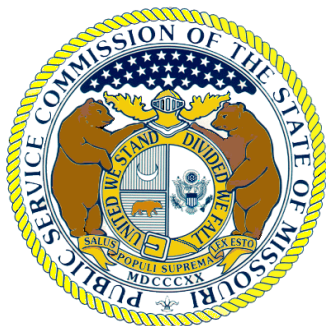
