**ORDER APPROVING TARIFF**

Issue Date: November 17, 2023

Effective Date: November 25, 2023

On October 26, 2023, The Empire District Electric Company d/b/a Liberty filed a revised tariff entitled Limited Large Customer Economic Development Rider, Schedule SBEDR. Liberty filed substitute sheets on November 16, 2023. The tariff bears a November 25, 2023 effective date.

The Commission's Staff filed a Recommendation on November 17, 2023. Staff stated that the Commission approved a Stipulation and Agreement in this case which recommended approval of a tariff sheet modifying The Empire District Electric Company's (Liberty) economic development rider (EDR) approved in a prior rate case (File No. ER-2012-0345). Staff stated that the pending tariff is consistent with the purpose of the Stipulation. Thus, Staff recommends approval of the tariff as substituted.

The Commission has reviewed the tariff and Staff's recommendation. Based on these filings, the Commission finds that the tariff sheet is in compliance with the Stipulation.

The Commission approves the tariff as ordered below. As the tariff is unopposed, and so that this tariff may go into effect expeditiously on the

requested effective date, the Commission will make this order effective in less than thirty days.
