On February 28, 2023, Cyndi Nealon filed a complaint against Missouri-American Water Company (MAWC).

Once evidence has been offered or prepared testimony filed, an applicant or complainant may dismiss an action only by leave of the commission, or by written consent of all the parties.

As prepared testimony has been has been filed in this matter, the Commission's leave to dismiss is required. No parties have filed an objection to Ms. Nealon's request to withdraw her complaint. The Commission will grant the request and close the file.
