ORDER AMENDING PROCEDURAL SCHEDULE

On November 13, 2023, the Commission adopted a procedural schedule in this matter.

The Commission will now amend the procedural schedule to add procedural requirements and a deadline for sharing of exhibits.

THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:

Evidentiary Hearing	December 1, 2023

2. The hearing will begin at **9:00 a.m.** and will be conducted via Cisco WebEx video and teleconference. The link, access telephone numbers, and access code to participate in the hearing will be emailed to all parties.

3. Those who need additional accommodations to participate in this hearing may call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

4. The parties shall comply with the following procedural requirements:

(A) For written testimony, all parties must comply with the requirements of Commission Rule 20 CSR 4240-2.130 for prepared testimony, including the requirement that testimony be filed on line-numbered pages.

(B) Ms. Bonacci may offer her complaint as a prefiled testimony exhibit without the line-numbering requirement of the previous paragraph.

(C) Ms. Bonacci may present live additional direct testimony herself or via other witnesses during the evidentiary hearing. Every Missouri West may present live additional rebuttal testimony during the evidentiary hearing.

(D) All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 20 CSR 4240-2.080.

(E) Exhibit numbers are assigned in the following manner:

Betty Bonacci	1-99
Every Missouri West	100-199
Commission Staff	200-299

(F) No later than November 29, 2023, each party shall provide, via e-mail, electronic copies of any exhibits the party intends to present as evidence to all other parties and to the presiding officer (exhibits@psc.mo.gov). The subject line of such e-mails shall include file number EC-2023-0433, and filenames of exhibits shall begin with "EXH" and the three-digit exhibit number – for example, "EXH001" for Ms. Bonacci's Exhibit No. 1. Copies of exhibits to be offered during cross-examination, which have not previously been shared with the other parties, shall be provided via e-mail to the other parties and the presiding officer during the evidentiary hearing. When those documents are offered during the hearing, they will be assigned a number from that party's number group.

5. This order is effective when issued.

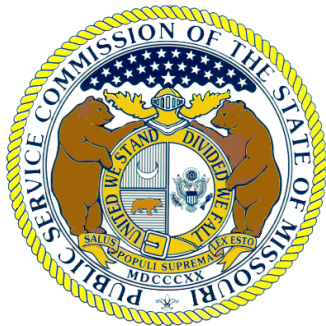
