STAFF'S COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), through counsel, and recommends that the Commission approve the tariff sheets Missouri- American Water Company ("MAWC") filed on November 15, 2023 (Tracking Numbers JW-2024-0067 and JS-2024-0068). The tariff sheets bear an effective date of December 15, 2023, but MAWC asks that the tariffs be allowed to take effect for service rendered on and after December 12, 2023.

On November 8, 2023¹ (effective on December 8), the Commission issued an Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity. The order granted MAWC a certificate of convenience and necessity for water and sewer service in Ironton, Missouri. The order was subject to the following tariff fStaffiling condition:

MAWC shall submit tariff sheets, to become effective before closing on the assets, to include adequately identified service area maps, service area written descriptions, rates and charges to be included in its EFIS tariffs P.S.C. MO No. 13 and 26, applicable to water and sewer service, respectively.

MAWC's tariffs filed on November 15 are designed to comply with this condition. Staff has reviewed the submission made under Tracking Numbers JW-2024-0067 and JS-2024-0068. Staff has concluded that the tariffs comply with the Commission's November 8 order and recommends the Commission grant the motion for expedited treatment and approve the tariffs, to go into effect on December 12, 2023.
