INTERCONNECTED VOICE OVER INTERNET PROTOCOL REGISTRATION

On November 14, 2023, Communication Innovators, Inc., pursuant to Section 392.550, RSMo, filed an application for registration to provide Interconnected Voice over Internet Protocol services (IVoIP) in the following exchanges:

Clay County and Buchanan County

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 150 days prior to the filing date of the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

1. Communication Innovators, Inc. is registered to provide IVoIP services in

the exchanges set forth in the affidavit attached to the application and restated above.

2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.

3. This order shall become effective on December 1, 2023.

4. This file shall be closed on December 2, 2023.
