ORDER GRANTING EXTENSION OF TIME

On October 13, 2023,¹ Liberty Utilities (Missouri Water) LLC d/b/a Liberty submitted an application requesting authorization to issue long-term debt in the amount of up to \$30 million.

The Staff of the Commission (Staff) was directed to file a recommendation or status report no later than November 22. On November 21, Staff timely filed a request for an extension of time to submit its recommendation. On November 17, Staff sent data requests to Liberty – which has resulted in a technical conference scheduled a November 27.

Staff stated it anticipated it will be able to file its recommendation by December 22. The Commission finds the request for an extension of time reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than December 22, 2023, Staff shall file a Recommendation or a status report regarding its Recommendation.
2. This order shall be effective when issued.
