## ORDER APPROVING REVISED COMPLIANCE TARIFF SHEET

Issue Date: November 21, 2023

Effective Date: December 8, 2023

On August 30, 2023,<sup>1</sup> the Commission issued an *Order Granting Certificate of Convenience and Necessity* (CCN) in this matter, to be effective on September 29. The order granted Spire Missouri, Inc., d/b/a Spire, a CCN to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Johnson County, Missouri, as a further expansion of its existing certificated area.

On August 31, Spire filed a revised tariff sheet, bearing an effective date of September 30 and assigned Tracking No. JG-2024-0029, purporting to comply with the terms of the Commission’s August 30<sup>th</sup> order. On September 6, the Staff of the Commission (Staff) filed a recommendation that the Commission approve the revised tariff sheet, which the Commission did on September 14.

On November 8, Spire filed a second revised tariff sheet, bearing an effective date of December 8 and assigned Tracking No. JG-2024-0062. Spire stated in its filing that the

first revised sheet incorrectly incorporated Section 18, Township 46, Range 31 West in Johnson County and that the second revised tariff sheet corrects the certificated area so that it complies with the Commission's August 30<sup>th</sup> order, incorporating Section 16, Township 46 North, Range 25 West in Johnson County.

At the request of the Commission, Staff reviewed Spire's second revised tariff sheet and determined that it complies with the Commission's August 30<sup>th</sup> order.

The Commission will approve Spire's second revised tariff sheet. To enable the tariff sheet to become effective on the date requested by Spire, the Commission finds it reasonable to make this order effective in less than 30 days.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheet filed on November 8, 2023, and assigned Tracking No. JG-2024-0062, is approved to become effective December 8, 2023. The approved tariff sheet is as follows:

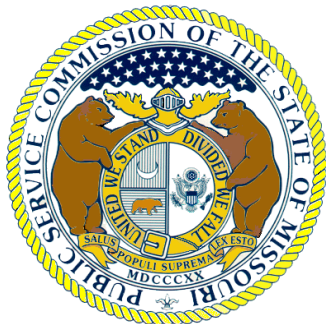
