ORDER GRANTING REQUEST FOR MEDIATION AND SUSPENDING SCHEDULE

On November 8, 2023,¹ Mr. Jerry Swartz filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. Mr. Swartz requested mediation in his complaint. The Commission directed a response from Ameren Missouri regarding the complaint.

On November 14, Ameren Missouri filed its *Notice of Agreement to Participate in Mediation*. As the parties agree in seeking mediation, the Commission will grant the request for mediation.

Commission Rule 20 CSR 4240-2.125(2)(C) suspends the procedural schedule during the mediation process; the deadlines imposed by regulation or order are tolled pending mediation, specifically here, Ameren Missouri's answer to the underlying complaint.
