ORDER SETTING PROCEDURAL SCHEDULE

Issue Date: November 22, 2023

Effective Date: November 22, 2023

On August 7, 2023, Judith Turner-Davis filed an application with the Commission requesting a change of electric supplier from Evergy Missouri West, Inc. d/b/a Evergy Missouri West to Platte-Clay Electrical Cooperative.

On November 3, 2023, the Commission ordered the parties to collaborate on a joint proposed procedural schedule to be filed by the Staff of the Commission (Staff). On November 17, 2023, Staff filed a joint proposed procedural schedule on behalf of all parties. The Commission will adopt the procedural schedule proposed by the parties with a minor change to the start time of the evidentiary hearing. The Commission will also address additional procedural matters.

THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:

Last Day to Request Discovery	-	November 17, 2023
Joint Stipulation of Facts	-	December 1, 2023
List of Issues, Witnesses, and Exhibits; Order of Cross-Examination; and Order of Opening Statements	-	December 12, 2023

- Statements of Position** - **December 22, 2023**
- Evidentiary Hearing** - **January 4, 2024**
(starting 11:00 a.m.)
- Initial Briefs** - **January 19, 2024**
- Reply Briefs** - **February 2, 2024**

2. The parties shall comply with the following procedures:

- (a) The parties agree to waive prefiled testimony and take testimony live at the evidentiary hearing.
- (b) Although not all parties may agree upon how each issue should be described or on whether a listed issue is in fact a proper issue in this case, the parties shall agree upon and file a list of the issues to be heard, the witnesses to appear during the hearing, the order in which they will be called, and the order of cross-examination for each witness. The list of issues should be detailed enough to inform the Commission of each issue that must be resolved. The Commission will view any issue not contained in this list of issues as not requiring resolution by the Commission.
- (c) Each party shall file a simple and concise statement summarizing its position on each disputed issue.
- (d) All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 20 CSR 4240-2.080. Briefs shall follow the same list of issues as filed in the case and must set forth and cite the proper portions of the record concerning the remaining unresolved issues that are to be decided by the Commission.
- (e) Exhibit numbers are assigned in the following manner:

Evergy Missouri West	100-199
Platte-Clay Electric Cooperative	200-299
Staff of the Commission	300-399

- (f) No later than December 28, 2023, each party shall provide, via e-mail, to all other parties and to the presiding officer (exhibits@psc.mo.gov) electronic copies of any exhibits the party intends to present as evidence. If a party does not utilize e-mail, paper copies of exhibits, in lieu of electronic copies, may be mailed via the U.S. Postal Service or other courier. Copies of exhibits to be offered during cross-examination, which have not previously been shared with the other parties, shall be provided either via paper copies

or via e-mail to the other parties and the presiding officer during the evidentiary hearing. When those documents are offered during the hearing, they will be assigned a number from that party's number group. If a document has not previously been shared with the other parties and is being marked for use at the hearing, the party using the document shall have sufficient copies of the document to provide a copy not only to the court reporter, but also to each of the Commissioners, the presiding officer, and all other parties.

3. The hearing shall be held at the Commission's office at the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri, beginning at 11:00 a.m. This building meets accessibility standards required by the Americans with Disabilities Act. 4. Parties and witnesses may appear in person or remotely via WebEx telephone or video conference.
