ORDER DIRECTING THE FILING OF BRIEFS REGARDING THE ISSUE OF THE COMMISSION'S JURISDICTION

On October 20, 2020, a joint application was filed with the Missouri Public Service Commission requesting either that the Commission approve an acquisition of certain transmission assets, or that the Commission find it lacks jurisdiction over the matter. Subsequently, the Staff of the Missouri Public Service Commission (Staff) requested the Commission suspend the obligation for Staff to file its recommendation and direct a status report filing on January 31, 2021. Staff indicated it wanted to wait until it becomes clear that multiple changes in ownership and control of the transmission assets at issue will not be occurring in the near future as a result of pending litigation in federal court before offering its recommendation regarding the merits of the proposed acquisition. Staff cited a motions hearing scheduled in the federal court case on January 12, 2021.

In a joint response to Staff's motion, GridLiance High Plains LLC, GridLiance GP, LLC, and GridLiance Holdco, LP ("GridLiance"), and NextEra Energy Transmission

Investments, LLC, and NextEra Energy Transmission, LLC ("NextEra Entities") noted that Staff's request would also suspend the portion of its recommendation addressing whether the Commission has jurisdiction over the matter. GridLiance and the NextEra Entities suggested January 18, 2021, as a due date for Staff's recommendation.

The Commission, on its own motion, will request briefs from all parties addressing whether the Commission has jurisdiction over the matter. As jurisdiction would be a dispositive issue, and in light of the request for expedited treatment, the Commission will continue moving forward with addressing that portion of the application.

This order makes moot the request of GridLiance and NextEra Entities to require the filing of a recommendation from Staff by January 18, 2021, and also eliminates the requirement that Staff's recommendation address whether the Commission has jurisdiction over this matter. If the Commission later determines that it does have jurisdiction, it may order Staff to file a recommendation regarding the merits of the application.

THE COMMISSION ORDERS THAT:

1. Staff shall, and any other party may, file a brief addressing whether the Commission has jurisdiction over this matter on or before January 19, 2021.¹

2. This order shall be effective when issued.
