On January 8, 2021, Union Electric Company d/b/a Ameren Missouri filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission for approval to sell an asset to its affiliate Ameren Transmission Company of Illinois. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.
