On December 10, 2021, Gridliance High Plains LLC (Gridliance HP) filed an application with the Missouri Public Service Commission for approval of the sale of certain public utility assets. Gridliance HP requests the Commission grant it authority to sell approximately 10 miles of 69 kV transmission lines and related facilities located in Christian and Greene Counties to the Missouri Joint Municipal Electric Utility Commission (MJMEUC). On December 30, 2021, MJMEUC filed its application to intervene in this matter. More than ten days have passed since that application to intervene was filed and no one has responded to the application.

The Commission finds that allowing MJMEUC to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.
