The Missouri Renewable Energy Standard rulemaking workshop will be held at 9:00 a.m. on March 9, 2009 in the Governor Office Building ballroom (Conference Room 450), 200 Madison Street, Jefferson City, MO. There is a city parking garage across Madison Street from the workshop location. Appropriate attire for the workshop will be business casual.

The workshop will be webcast. To observe the workshop via the webcast, go to the Missouri Public Service Commission website (www.psc.mo.gov). Staff will then prepare a draft rule for submission to the Commission. After the proposed rule is approved by the Commission, it will be printed in the Missouri Register and formal comments can be submitted.
