## ORDER DIRECTING RESPONSE

On August 29, 2023,<sup>1</sup> the Commission ordered these proceedings stayed at the request of The Empire District Electric Company, d/b/a Liberty, with the agreement or non-objection of Mr. Lindsey and New-Mac Electric Cooperative, Inc. (New-Mac Electric). On November 3, Liberty filed a status update that stated that all service concerns raised by Mr. Lindsay have been addressed.

The November 3 filing also requested dismissal of Mr. Lindsay's application, and stated that the filing had been shared with Mr. Lindsay prior to its filing, implying that Mr. Lindsay agreed to dismiss his application.

As the Commission needs confirmation of Mr. Lindsay's intent to dismiss his application to change suppliers, it will order Mr. Lindsay to file a response whether he intends to dismiss his application or not.

If Mr. Lindsay does not respond, then the Commission may dismiss his application for good cause after a minimum of ten days' notice to all parties, pursuant to Commission Rule 20 CSR 4240-2.116(4).
