## ORDER CANCELING AUTHORITY

Issue Date: November 28, 2023

Effective Date: December 28, 2023

On March 24, 2023, the Staff of the Commission (Staff) filed a motion asking the Commission to cancel the registration of service authority of MGM Interconnect, LLC (MGM or The Company). The Commission granted MGM a registration to provide interconnected voice over internet protocol (IVoIP) service authority in Case No. DA-2020-0030.

Staff's motion states that MGM failed to file its annual reports for calendar years 2019, 2020, and 2021. Staff recommended that the Commission cancel the Company's registration.

The Commission has the authority to cancel a company's authority pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's motion, the Commission finds that the registration granted to MGM shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The registration to provide interconnected voice over internet protocol service granted to MGM in File No. DA-2020-0030 is cancelled.
2. This order shall become effective on December 28, 2023.
3. This case may be closed on December 29, 2023.
