**ORDER APPROVING TARIFFS**

Issue Date: November 29, 2023

Effective Date: December 12, 2023

On June 22, 2023, Missouri-American Water Company (Missouri-American) filed the above-referenced application. The Commission approved the application on November 8, 2023. In the order approving the application, the Commission ordered Missouri-American to file tariffs.

Missouri-American filed tariffs with Tracking Nos. JW-2024-0067 and JS-2024-0068 on November 15, 2023. The tariffs bear an effective date of December 15, 2023. However, because Missouri-American has a December 13, 2023 closing date on the assets the Commission has authorized it to purchase, Missouri-American filed a Motion for Expedited Treatment. That motion asks the Commission to approve the tariffs no later than December 12, 2023.

The Commission's Staff filed a Recommendation on November 21, 2023. The Recommendation stated that the Commission should approve the tariffs on an expedited basis. No other responses were received.

The Commission finds that the tariffs comply with the Commission's November 8, 2023 order. The Commission will approve the tariffs. The Commission further finds that Missouri-American has demonstrated good cause for the tariffs to become effective on December 12, 2023.

**THE COMMISSION ORDERS THAT:**

1. The Motion for Expedited Treatment is granted.
2. The tariffs filed by Missouri-American on November 8, 2023, and assigned Tracking No. JW-2024-0067 and JS-2024-0068, are approved to become effective on December 12, 2023.
3. This order shall be effective December 12, 2023.
