**ORDER DENYING APPLICATION FOR REHEARING**

On October 25, 2023, the Commission issued its *Report and Order* effective November 4, 2023, regarding the application of Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) to implement general rate increases for water and sewer service. On November 3, 2023, the Office of the Public Counsel filed a timely application for rehearing.

Section 386.500.1, RSMo (2016), states that the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, the application for rehearing does not demonstrate sufficient reason to rehear the matter.

The Commission will deny the application for rehearing.

**THE COMMISSION ORDERS THAT:**

1. The *Office of the Public Counsel's Motion for Reconsideration or in the Alternative, Application for Rehearing*, filed on November 3, 2023, is denied.
2. This order shall be effective when issued.
