On October 12, 2023, the Commission issued its *Order Partially Modifying the Commission's 2010 Order Regarding ARCs*. That order has an effective date of December 11, 2023. On November 7, 2023, Evergy Metro, Inc. d/b/a as Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, "Evergy" or the "Company") filed a *Motion for Clarification*.
