On September 1, 2021, the Commission directed its Staff to investigate Spire Missouri, Inc. d/b/a Spire's compliance with the Commission's gas safety rules related to the mechanical joining qualifications of its employees. On November 15, 2023, after a thorough investigation and numerous status reports, Staff filed its investigation report. Staff's investigation report identifies some alleged violations of the Commission's pipeline safety standards set out in 20 CSR 4240-40.030 and sets out nine recommendations. Additionally, Staff requests that the Commission direct Spire to respond to Staff's report and recommendations with an action plan within 60 days.

Spire made an initial response requesting until January 19, 2024 to file a complete response to Staff's report and recommendations. Spire indicates that Staff does not object to its request. The Commission finds the request reasonable and will set a time for Spire to respond to Staff's report and recommendations.

THE COMMISSION ORDERS THAT:

1. Spire shall file a response to Staff's investigation report and recommendations no later than January 19, 2024.

2. This order shall be effective when issued.
