## ORDER DIRECTING THE SUBMISSION OF DOCUMENTS AND SCHEDULING FIRST STATUS CONFERENCES

Issue Date: November 29, 2023

Effective Date: November 29, 2023

On November 17, 2023, the Commission directed Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) to submit an estimated timetable for Evergy's pre-securitized bond issuance process. Evergy submitted that estimated timetable on November 21, 2023.

Sections 393.1700.2(3)(c)c and 393.1700.2(3)(h), RSMo., require that the structuring and pricing of the securitized utility tariff bonds are reasonably expected to result in the lowest securitized utility tariff bond charges consistent with market conditions and the terms of the Commission's *Amended Report and Order*. So the Commission may track that these requirements are being fulfilled, the Commission will direct Evergy to submit to the Commission copies of any documents related to the Securities and Exchange Commission (SEC) registration of the Securitized Utility Tariff Bonds (which would include any SF-1s, the Indenture, Servicing Agreement, prospectus, and Limited Liability Company Agreement for the Special Purpose Entity) submitted to or received from the SEC within two days of submission or receipt.

The Commission will schedule a WebEx status conference with the parties to keep the Commission appropriately informed. The parties, either jointly or separately, must provide the Commission with a summary of any outstanding issues prior to each status conference. Evergy will be directed to make its underwriter available for the status conference

**THE COMMISSION ORDERS THAT:**

1. Evergy must submit to the Commission copies of any documents related to the SEC registration of the Securitized Utility Tariff Bonds submitted to or received from the SEC within two days of submission or receipt.

2. The Commission will hold a status conference beginning December 5, 2023, at 11:00 a.m. The status conferences will be held via WebEx, and information to attend the status conference will be sent to counsel for the parties prior to the status conference. Evergy and Staff must appear at the status conferences, but other parties are not required to attend.

3. Evergy shall make its underwriter available at the status conference to answer Commission questions.

4. Any outstanding issues must be submitted to the Commission two business days prior to any status conference.

5. This order shall be effective when issued.

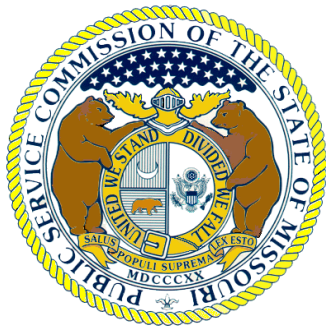
