On September 28, 2023,¹ Union Electric Company d/b/a Ameren Missouri filed a tariff revision and supporting testimony to modify rates under its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM).

The Commission directed its Staff to file a recommendation. On November 22, Staff filed a request for an extension of time to December 19 due to remaining data requests.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension of time is granted.
2. Staff shall file a recommendation regarding its examination and analysis of Ameren Missouri's RESRAM no later than December 19.
3. This order shall become effective when issued.
