**ORDER DIRECTING A STAFF TARIFF RECOMMENDATION  
AND SETTING TIME FOR RESPONSES**

On November 21, 2023, The Empire District Electric Company d/b/a Liberty filed tariff sheets to comply with the Commission's September 14, 2023, order extending Liberty's Missouri Energy Efficiency Investment Act Cycle 1 an additional year. Those tariff sheets bear an effective date of December 21, 2023. The Commission will direct its Staff to analyze the tariff sheets and file a statement about whether those tariff sheets comply with the Commission's order. The Commission will also set a deadline for any responses to Liberty's compliance tariff sheets.

**THE COMMISSION ORDERS THAT:**

1. Staff must file a recommendation about Liberty's tariff sheets no later than December 7, 2023.
2. Any other responses to Liberty's tariff sheets must be filed no later than December 7, 2023.

3. This order is effective when issued.
