On September 29, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of the unregulated Country Life Acres sewer system. The Commission ordered its Staff (Staff) to file a Recommendation or a status report indicating when its Recommendation would be filed.

On November 29, Staff filed a Status Report indicating it expects to file its Recommendation on or before December 6, and requested the Commission order such a due date.

The Commission finds the requested due date reasonable and will grant Staff's request.

THE COMMISSION ORDERS THAT:

1. Staff's request is granted. Staff shall file a Recommendation no later than December 6, 2023.
