On September 29, 2023,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the North Oak Sewer District, Inc. (North Oak), which is providing sewer service in Warren County, Missouri. The Commission ordered its Staff (Staff) to file a Recommendation or a status report indicating when its Recommendation would be filed.

On November 29, Staff filed a Status Report indicating it expects to file its Recommendation on or before January 12, 2024, and requested the Commission order such a due date.

The Commission finds the requested due date reasonable and will grant Staff's request.

THE COMMISSION ORDERS THAT:

1. Staff's request is granted. Staff shall file a Recommendation no later than January 12, 2024.


