**NOTICE**


On February 16, 2010 I received a letter dated February 2, 2010 from Thomas R. Voss, President and CEO of Ameren Corporation addressed to me personally.

AmerenUE is a party to the above captioned contested case. It is important to note that no Missouri law or Commission rule creates an absolute bar to all communications between Commissioners and parties to cases before the Commission. Missouri law and Commission rules do however create notification and disclosure requirements determined by the content of the communication and at the time at which the communication occurs.

Section 386.210 addresses circumstances where the communication addresses the “merits of the specific facts, evidence, claims, or positions presented or taken” when an evidentiary hearing has been scheduled, and 4 CSR 240 – 4.020 addresses conduct during proceedings before the commission, with subsections (6) – (8) addressing *ex parte* communication in particular. In this case, an evidentiary hearing is scheduled, as referred to in Section 386.210.3, and is similar to the “on-the-record proceeding [ ] for hearing” referred to in 4 CSR 240-4.020(7). My review of the letter and attachment does not indicate that it relates to this case, nor does it make clear that it relates to substantive

issues in this case, addresses the merits of the specific facts, evidence, claims, or positions presented or taken.

Out of an abundance of caution and to ensure transparency, I have prepared a report in accordance with 4 CSR 240-4.020(8) regarding the communication, distributed that report in conformance with the Commission's rule. In addition, pursuant to 386.210(3)(a), the communication is being disclosed to AmerenUE, the Office of the Public Counsel and all parties to the case by filing a copy of the communication in the case file and serving it upon all parties of record via the Commission's electronic filing system.
