ORDER DIRECTING NOTICE, ESTABLISHING TIME FOR FILING REQUESTS TO INTERVENE, AND ESTABLISHING TIME FOR FILING RECOMMENDATIONS

Issue Date: March 29, 2019 Effective Date: March 29, 2019

This order directs that notice of this case be sent to all certificated interexchange and basic local exchange telecommunications companies in the state of Missouri and to the North American Numbering Plan Administrator. The order also establishes dates for the filling of requests to intervene and for the filling of recommendations.

On March 29, 2019, MCImetro Access Transmission Services Corp. d/b/a Verizon Access Transmission Services (Verizon Access), filed an Application and Motion for Expedited Treatment requesting that the Missouri Public Service Commission review and reverse a decision of the North American Numbering Plan Administrator (NANPA), NeuStar, Inc., to withhold certain numbering resources from Verizon Access. The numbering resources Verizon Access requested consist of a 7xxx or 8xxx contiguous range of DID numbers for NPA 314 or 636 to allow Nestle USA to centralize its facsimile services across the country. Verizon asks the Commission to grant its request within 10 business days (April 12, 2019).

The Commission finds that proper persons should be allowed to file a request for intervention or a motion for hearing. Therefore, the Commission will set a time for interventions as directed below. The Commission will also direct its Data Center to send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri. In addition, the Data Center shall send a copy of this order to NANPA.

The Commission will also direct its Staff to file a recommendation and will establish a date by which any other party wishing to respond may file a recommendation.

IT IS ORDERED THAT:

- 1. The Data Center shall send a copy of this order to each certificated interexchange and basic local exchange telecommunications company in Missouri and to the North American Numbering Plan Administrator, NeuStar, Inc.
- 2. Any party wishing to intervene or to request a hearing shall do so by filing an appropriate pleading no later than April 5, 2019, with:

- 3. The Staff of the Commission shall file a recommendation regarding the application of Verizon Access, or shall file a status report indicating when a recommendation will be filed, no later than April 5, 2019.
- 4. Any other party that wishes to file a recommendation regarding the application of Verizon Access, shall do so no later than April 5, 2019, and shall file its recommendation simultaneously with its application to intervene.

5. This order shall be effective when issued.
