Section 536.200.2, RSMo 2000 requires the Commission to review the fiscal note that it attached to its 2017 revision of Chapter 4 rules at the end of the first full fiscal year following the implementation of the rules. As part of that review, the Commission invites interested stakeholders to offer comments about whether the estimated costs to comply with the rules set out in the fiscal notes have proved to be accurate.

1. Comments regarding the actual cost of compliance shall be filed with the Commission by May 3, 2019.
2. The Commission's Data Center shall provide a copy of this order to all persons who filed comments regarding the rule.
3. This order shall become effective on April 2, 2019.


