NOTICE OF DISMISSAL

Issue Date: April 5, 2019

On March 21, 2019, the Staff of the Missouri Public Service Commission ("Staff") filed a Complaint against Campus Communications Group, Inc. (the "Company"). The Complaint alleged that the Company had not filed its 2017 Annual Report. On March 22, 2019, the Commission issued a Notice of Contested Case and Order Directing Filing. On April 4, 2019, the Staff filed a Motion to Dismiss, stating that on March 28, 2019, the Company had filed its 2017 annual report.

Commission Rule 4 CSR 240-2.116(1) states that a party may dismiss a complaint without an order of the Commission before prepared testimony or oral evidence has been offered. The parties have not offered prepared testimony or oral evidence. The Commission, therefore, will take notice of the dismissal. This case shall be closed.

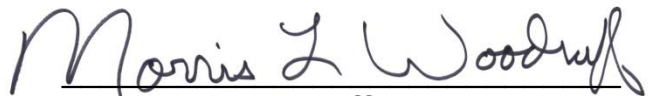
