CORRECTED ORDER APPROVING COMPLIANCE TARIFFS

This corrected order changes the effective date listed at the top of the order to December 16, 2023. It incorrectly listed December 5, 2023, in the original order.

On November 8, 2023,¹ the Commission issued its *Report and Order Approving Second Addendum to an Existing Territorial Agreement* (Order).

On November 16, Ameren Missouri filed a tariff sheet purporting to be in compliance with the Commission's Order. That tariff sheet was assigned Tracking No. JE-2024-0069 and had a proposed effective date of December 16.

On December 4, the Staff of the Commission (Staff) filed its Recommendation with an attached Memorandum determining that the tariff sheet complies with the Order. Upon reviewing the pleadings, the Commission finds Ameren Missouri's proposed tariff sheet complies with the Commission's Order and will approve it. To enable the tariff sheet to become effective on the date requested, the Commission finds it reasonable to make this order effective in less than 30 days.
