On March 13, 2019, Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities filed an application with the Missouri Public Service Commission ("Commission") seeking authority for Liberty Utilities to purchase substantially all of the assets of Franklin County Water Company, Inc. The Commission directed its Staff to inform the Commission of when it would be able to file a recommendation, and on April 9, 2019, Staff indicated that it anticipates filing its recommendation or a status report no later than June 10, 2019. Staff will be directed to comply with that deadline.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation or a status report regarding Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities' application no later than June 10, 2019.
2. This order shall become effective when issued.


