On April 11, 2019, intervenors Joseph and Rose Kroner filed a motion to compel Grain Belt Express Clean Line, LLC, to answer their discovery request. The motion asks the Commission to order Grain Belt to admit the accuracy of two pages of a document they submitted to Grain Belt as part of a request for admissions. Because the hearing in this case is set to begin on April 23, the Kroners ask the Commission to expedite its consideration of their motion. The Commission will direct Grain Belt to respond to the Kroner's motion in an expedited manner.

THE COMMISSION ORDERS THAT:

1. Grain Belt Express Clean Line, LLC shall respond to the Motion to Compel Grain Belt to Answer Discovery Request no later than April 15, 2019.
2. This order shall be effective when issued.
