On November 16, 2023, the Commission approved a stipulation and agreement extending Evergy Missouri Metro and Evergy Missouri West's (Evergy) Missouri Energy Efficiency Investment Act Cycle 3 programs an additional year.

On December 1, 2023, Evergy filed proposed tariff revisions, Tracking Nos. JE-2024-0079 and JE-2024-0080, which bear an effective date of January 1, 2024, to comply with the Commission's order. The Commission will direct its Staff to file a recommendation informing the Commission of whether the company's tariff revisions comply with the Commission's order and the approved stipulation and agreement, and will set a time for filing other comments.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation about Evergy's compliance tariff sheets, Tracking Nos. JE-2024-0079 and JE-2024-0080, no later than December 14, 2023.

2. Any other comments about Tracking Nos. JE-2024-0079 and JE-2024-0080 shall be filed no later than December 14, 2023.
