**RESPONSE TO STAFF'S REPLY TO THIRD MOTION TO AMEND  
PROCEDURAL SCHEDULE**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri"), and hereby files this *Response to Staff's Reply to Third Motion to Amend Procedural Schedule*, as follows:

1. On December 7, 2023, Ameren Missouri filed its third motion to amend the procedural schedule in this case.
2. On December 11, 2023, the Staff of the Missouri Public Service Commission ("Staff") filed a response to the Company's motion and proposed its own schedule, which is very similar to the schedule proposed by the Company. The dates for Expedited Transcripts, Initial Briefs and Reply Briefs are moved by one day and the discovery deadline was redefined so that responses to data requests are due by the deadline date rather than just propounded by that date.
3. Ameren Missouri does not object to the Staff's proposal.
4. As was explained in the Company's third motion to amend the procedural schedule, Ameren Missouri requests the Commission rule upon this request at this week's Agenda.

**WHEREFORE**, the Company respectfully requests that the Commission make and enter its order amending the procedural schedule to reflect Staff's proposed schedule and that the order be issued at this week's Agenda.
