### ORDER GRANTING MOTION TO INTERVENE

Issue Date: April 15, 2019 Effective Date: April 15, 2019

On February 12, 2019, Elm Hills Utility Operating Company, Inc. ("Elm Hills") filed applications with the Missouri Public Service Commission requesting that the Commission grant it Certificates of Convenience and Necessity ("CCN") for both a water system and sewer system in Pettis County, Missouri, in an area known as Stone Creek near the city of Sedalia. The Commission set March 6, as the deadline for intervention.

On April 3, the City of Sedalia filed an application to intervene out of time. In its application, Sedalia noted that the service areas for which the CCNs are sought are within Sedalia's city limits. No objections to Sedalia's application to intervene were received.

Commission Rule 4 CSR 240-2.075(10) allows for the addition of late interveners upon a showing of good cause and a definitive statement as whether the applicant accepts the record established in the case. Sedalia's motion affirmatively accepts the record established. Sedalia raises an issue of boundaries of the proposed CCNs, and is the municipality the CCNs would allegedly affect. With no objections received, the Commission finds that good cause is shown. The Commission will grant the motion to intervene.

### THE COMMISSION ORDERS THAT:

- 1. The City of Sedalia's Application to Intervene Out of Time is granted.
- 2. This order shall be effective when issued.
