ORDER GRANTING EXTENSION OF TIME TO FILE STAFF RECOMMENDATION

On October 26, 2023, Heidi Orton filed an application with the Commission requesting a change of electric supplier from Evergy Missouri West, Inc. d/b/a Evergy Missouri West to Platte-Clay Electric Cooperative, Inc.

On October 27, 2023, the Commission directed the Staff of the Commission (Staff) to file a recommendation regarding the application, or a report stating when it expected to file a recommendation, no later than December 11, 2023. On December 11, 2023, Staff filed a status report, followed later that day by a corrected status report, stating that, due to recently received responses to data requests, Staff expects to complete its investigation, report, and recommendation in an additional 45 days.

The Commission will extend the deadline for Staff to file its investigative report and recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file its investigative report and recommendation regarding Ms. Orton's application no later than January 25, 2024.

2. This order is effective when issued.
