On April 2, 2019, KCP&L Greater Missouri Operations Company ("GMO") filed a Notice of Bill Credits. In that notice, GMO stated that it mistakenly provided bill credits to certain accounts, caught the error, and reversed those credits. GMO requests to give the funds from those credits, which is \$16,871.61, to the Mid-America Assistance Coalition so that it can provide energy assistance to needy customers.

Commission Rule 4 CSR 240-2.080(13) states that parties have ten days to respond to pleadings unless otherwise ordered. The Commission issued no order to the contrary of this rule, ten days have elapsed since GMO's request, and no party has objected. Thus, the Commission will take up GMO's request unopposed.

The Commission finds GMO's request reasonable, and will grant it.

- KCP&L Greater Missouri Operations Company is authorized to release the above-referenced funds to Mid-America Assistance Coalition.
