On February 14, 2019, the Commission issued its *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* (“Order”) approving the Application of Confluence Rivers Utility Operating Company, Inc., (the “Company”) to acquire certain water and sewer assets and the existing certificates of convenience and necessity (“CCN”) held by the selling companies and granting new CCNs for the areas served by the selling companies that had none. As a part of the Order, the Commission ordered the Company to “file adoption notice tariff sheets for each tariff currently in effect for the regulated Sellers, as 30-day filings, within ten (10) days of closing on the respective assets.” On April 15, 2019, the Company filed *New Tariffs* (“tariff sheets”).¹ Each of the tariff sheets bears an issue date of April 15, 2019, and a proposed effective date of May 15, 2019. The Commission will order the Staff of the Missouri Public Service Commission to file a recommendation on the tariff sheets.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a recommendation on the tariff sheets² no later than April 27, 2019.
2. If the Office of Public Counsel or any other party wishes to file a recommendation, it shall do so no later than April 27, 2019.
3. This order will be effective when issued.
